Wetlands in Baltic Green Belt (Germany) secure

In February 2010, after one year of discussions between authorities, the Rostock harbour association and environmental NGOs, a compromise was achieved with respect to the planned extension of the Rostock harbour. The extension will affect valuable coastal marsh habitats, which is unacceptable from the environmental point of view. BUND MV and the NABU (BirdLife) pointed out that parts of the wetlands further north of the harbour should be declared compensation areas. In the

end, an area of 4,4 ha in the estuary of Peetzer stream was declared. Even though, this area is not large in total, this is a meaningful achievement, as this area is located right next to other areas suitable for renaturation.

GAJA pushes for reducing animal fertiliser input ...

... to Polish coastal waters during high level political meetings in Helsinki. Participating in the 5th HELCOM BSAP Stakeholder Conference and the 31st Baltic Marine Environment Protection Commission Meeting, held in Helsinki, on 3-5th March 2010, the Polish Green Federation GAJA put substantial problems related to the improper storage and use of animal fertilisers, as well as the recognition of factory farms as a point source of nutrients to the Baltic coastal waters. Eutrophication is still the main threat to the Baltic Sea environment. In Poland. regulations concerning fertilisers management haven't been accommodated to the requirements in the revised Annex III to the Helsinki Convention. This discrepancy represents a significant obstacle to the recognition by Poland of the criteria proposed by HELCOM on including deleting of point agricultural Hot Spots (industrial animal farms). By signing the Baltic Sea Action Plan, in November 2007, both the Polish Ministry of Agriculture and the Ministry of Environment were aware of the binding legal status. HELCOM Ministerial Conference and Meeting

On May 18th -20th, 2010, the HELCOM Ministerial Conference is to be held in Moscow. The National Implementation Programmes to achieve the objective of the HELCOM Baltic Sea Action Plan to radically reduce pollution to the marine environment and restore its good ecological status by 2021 will be presented at the Meeting and should include concrete measures to reach the provisional county-wise nutrient pollution reduction targets as set in the Baltic Sea Action Plan. New and revised recommendations will adopted in Moscow. includina measures combat hazardous to substances, ensure safe shipping and response to maritime oil pollution.
