PROGRAM and MINUTES $26^{th} - 29^{th}$ of May 2014

25th of May. Arrival.

From <u>Bergen Airport, Flesland</u> you take the <u>airport bus</u> to Bergen City. Hotel "Scandic Neptun" Valkendorfsgate 8.

19.00 Meet in the hotel lobby in Bergen city.

26th of May

Breakfast Safetur project meeting in the hotel 9.00 Inception began with initial greetings from Mr. Jan Tjosaas, GS of Eurogites. Presentation by manager of <u>Ekstremsportveko</u> (Extreme Sport Week), Sofie Torlei Olsen. The theme of the presentation is *focus on safety*. Coffee 12.00 Lunch break 13.00 Safetur meeting continues. Coffee. 18.00 End of meeting. 19:00 Sightseeing in Bergen (walking).





27th of May

Breakfast

9:00 – 10:00 Safety aspects in marketing of Norway. Guest speaker - Kristian B. Jørgensen, director of Fjord Norway – director.

10:00 Departure from the hotel by bus.

Had a stop at <u>Steinsdalsfossen</u> (waterfalls). The waterfall is one of the most visited in Norway. A trail goes behind it where visitors can walk dry "into" the rumbling water. Steinsdalsfossen is 46 meters high. This is start of the Hardanger tourist road - one of 18 tourist roads of Norway.

- Possible enhancements for the footpath from the car park up to and under the waterfall.
- Visitor reception center information on risks and adequate behaviour
- Parking "nice" construction of parking lots but their metal frames cut bus tyres





12:00 Arrived at Hardingasete <u>http://hardingasete.no/kurs-konferanse.php</u>

Hardingasete is a unique seminar and conference centre where the old meets the new. Hardingasete is created from 20 houses from the western region of Norway, dating from the period from 1600-1870. A number of old houses have been moved to the spot, fitted with both antique furniture and the comforts of modern bathrooms and kitchens. Boathouse and floating embarkment on the lakeshore – protection measure were checked. Electric ity installation in wooden construction – maintenance problem with accident / fire risk.

13:00 – 17.00 Workshop and discussion on European Safety and security aspects in rural tourism Presentation Project results "Practice based training tool for safety and security in European rural tourism", SAFETUR, 2012-1-LV1-LE005-03389:

- Customer survey results, answers from respondents on graphic diagrams.

- Discussing the satisfaction received from rural tourism services in regards of SPECIFIC safety concerns.

Overnight stay at Hardingasete



28th of May

07:30 Breakfast

08:15 Departure for the study trip around Hardanger by bus. Introduction to the program during first part of transfer - Safety aspects on public transport, nature tours, nature trails, water activities, food and hygiene, licensing, and road signs.

08:40 Ferry from Tørvikbygd to Jondal (25 '). It is an opportunity to see the fjords from the "inside", provision of protection installation and equipment for passengers on land and on boat.

10:30 Arrival at <u>Hardangertun</u>. Tour and presentation by the marketing manager, Lars Instanes Coffee. Hardangertun is both a camping and an amusement park. Added active tourism services are

explained. They also have conference facilities. Discussion on the viability and problems of short season with high occupancy, versus most of the year with low coverage.

11:45 Depature from Hardangertun

12:30 Lunch break at <u>Syse Gard.</u> Syse Gard is a traditional fruit farm, and the owners also produce jam, apple juice etc. which is sold in the farm shop. Explanation of the history, requirements for production and sale to public, degustation and catering. Short tour of the fruit farm at the end of the visit.

14:00 Walking from Syse Gard to Hardanger Juice and Cider factory

14:15 Tour of <u>Hardanger Juice and Cider factory</u>. Tasting of different types of cider.

Hardanger Juice and Cider factory is located by the innermost part of the Hardanger Fjord at the fruit farm Lekve in Ulvik. They produce apple juice and cider from traditional recipes. In 2009 they also started







production of apple brandy. Transformation from farming activity into food production and a more service-orientated catering activity. Licensing and taxation for alcoholic beverages was discussed.



15:30 Departure from Hardanger Juice and Cider factory

16:30 Arrival at Vøringsfossen

Vøringfossen is the 3rd highest waterfall in Norway with a fall of 163 meters. It is perhaps the most famous waterfall in the country and a

> major tourist attraction on the way down from Hardangervidda to Hardangerfjord. In spite of high danger of falling off the edge right at the end of the parking area, there is no protection and only few warning signs. The full hiking path to a exposed viewpoint is unprotected, everybody can leave it and move right to the edge of the gorge. The protection at the viewpoint is equally very weak - low rails, no warning signs, etc. Several

deadly accidents per year are the consequence. Differences with regulation and access control in EU is discussed.

17:15 Departure from Vøringsfossen

17:45 Arrival, dinner, overnight stay at Eidfjord Fjell & Fjord Hotel

29th of May

09:00 Departure by bus towards Bergen

Stop at <u>Steinstø Fruktgard</u> for coffee and a tour of the beautiful gardens. The farm offers quality fruits and berries, homemade apple juice, different types of home made jam, jellies, a traditional spread "lefse", apple cake and several other delicious dishes. Visitor area and small parking is set right beside the main road, without any kind of protection (however, low traffic and good visibility). Business model and the seasonality of the business were again discussed with owners.
